
Weatherization Assistance Programs

- Funded by US DOE and US HHS
 - Provides income-eligible households with services that make their homes more energy efficient, protect the health and safety of occupants, and permanently reduce their energy costs
- Local Service Providers
 - Providers are regionally located to serve all communities in the State of Minnesota



Minnesota WAP Service Providers

- Regionally located
- Eligible to income qualified households
- Pre-qualified service providers
- Funding to perform energy audits and install energy-efficient conservation measures





Weatherization Assistance Programs

- Household Eligibility
 - Households must first apply for and be approved to receive Energy Assistance benefits
 - Household income must be below 200% of the federal poverty limit (\$47,700 for a family of 4)
- Dwelling eligibility
 - Homeowners and renters are eligible
 - Single family, mobile homes, multi-family
 - Certain conditions of the dwelling may need to be corrected prior to weatherization




Weatherization Assistance Programs

- Weatherization Services
 - Energy audit is conducted by the local agency, audit data is entered into a software that determines what measures would be cost effective
 - Projects typically require a combination of building shell, mechanical and electrical contractors
 - Certified Quality Control Inspectors verify that work was performed to DOE standards and complete tests to verify energy savings and safety



Weatherization Assistance Programs

- Contractors
 - Contact the local agency in your area if you're interested in weatherization projects
 - 31 counties are served by agencies that employ crew members, all others contract with building shell contractors
 - All agencies contract with mechanical and electrical contractors





Utility Incentives

Maximize Incentives

- Do homework
 - become familiar with local utility incentives
- Educate customers
 - inform customers about utility incentive offerings
- Maximize utility incentives
 - provide options for performance and cost
- Benefits of being reputable, informed contractor:
 - Up-sales + repeat sales + referrals

- Be financially resourceful

- Learn about available financial resources
 - Grants, rebates, tax incentives, loans
- Understand the approval process
 - institutions use different procedures and timelines
- Inform customers
 - identify project financing resources
- Assist customers
 - provide information to complete financing applications
